- SB 623      THOMPSON      HORTICULTURE** Provides relative to violations of the Horticulture Law. (gov sig)
- SB 627      THOMPSON      HORTICULTURE** Eliminates demonstrations of floral design work from the retail florist examination. (gov sig)
- SB 635      THOMPSON      HORTICULTURE** Consolidates the professions of horticulturalist and landscape contractor into one licensed profession known as "landscape horticulturist". (gov sig)
- SB 641      THOMPSON      AGRICULTURE/FOREST DEPT** Provides relative to the Boll Weevil Eradication Commission. (gov sig)
