Mr President and Fellow Members,

I come before you this afternoon with a heavy heart. SB 27, my bill on Senate Redistricting that I filed Tuesday, March 22^{nd} has been scheduled and rescheduled on six separate occasions before the Senate and Governmental Affairs Committee.

Since filing SB 27 eight days ago, the detailed maps and demographic data I submitted with the Precinct Lists were not placed on the Senate Website until today. Before today no one in Louisiana or the United States Justice Department has been able to view my Senate Redistricting Plan on the State Senate Website.

Members, this is not right.

In the meantime, SB1, authored by Senate President Chaisson, has been scheduled in Senate and Governmental Affairs; heard in Senate and Governmental Affairs; made Special Order of the Day for the Senate Floor; heard on the Senate Floor; passed out of the Senate; and sent over to the House of Representatives in less than 10 days.

It's ironic that SB27, which I have referred to as the 'Demographic Equity Plan,' has not been treated equitably in this process.

After filing SB 27 on Day Three of the Special Legislative Session; I have now been told that I will have the bill heard in the Senate and Governmental Affairs Committee next Monday, April 4, 2011; the Sixteenth Day of our 25-Day Special Session; and 13 days after initially filing SB 27.

My bill has little or no chance of make it through the Legislative Process before our April 13th Adjournment Day.

This is not how the People's Business is supposed to be handled.
