Any such disciplinary action shall be taken without regard to race, creed, or color and shall be subjected to review by the mayor and board of aldermen.

C. Notwithstanding any other provision of this Section to the contrary, the board of aldermen of the municipality may, upon recommendation of the mayor, contract with or enter into any cooperative endeavor with any law enforcement entity or officer within the parish in which the municipality is located for police services for said municipality.
