Taxable capital shall be determined as hereinafter provided in this Chapter. The tax levied herein in this Section is due and payable on any one or all of the following alternative incidents:

D. (1) For taxable periods beginning before January 1, 2023, the annual rates of tax shall be one dollar and fifty cents for each one thousand dollars, or major fraction thereof on the first three hundred thousand dollars of taxable capital and three dollars for each one thousand dollars, or major fraction thereof, in excess of three hundred thousand dollars of taxable capital.

(2) Except as otherwise provided in R.S. 47:601.1 or 601.2,

for taxable periods beginning on or after January 1, 2023, the annual rate of tax shall be two dollars and fifty cents for each one thousand dollars, or major fraction thereof, in excess of three hundred thousand dollars of taxable capital.

§601.2. Automatic rate reduction
A.(1) Beginning February 1, 2024, and each February first thereafter, if the prior fiscal year's actual corporation income and franchise tax collections as reported in the state's accounting system exceed the actual corporation income and franchise tax collections for the fiscal year ending June 30, 2019, as reported in the state's accounting system, adjusted annually by the growth factor provided for in Article VII, Section 10(C) of the Constitution, the corporation franchise tax rate in R.S. 47:601 for the tax year beginning the following January first shall be reduced as provided in Paragraph (2) of this Subsection.

(2) The amount of the reduction shall be calculated by

multiplying the rate by the difference between one and the percentage change in corporation income and franchise tax collections in excess of the corporation income and franchise tax collections for the 2018-2019 Fiscal Year adjusted annually by the growth factor as provided in Paragraph (1) of this Subsection. B. The actual corporation income and franchise tax collections and total general revenues used in the calculations required by this Section shall be certified by the Office of

Statewide Reporting and Accounting Policy.

(1) "Growth factor provided for in Article VII, Section 10(C) of the Constitution" means the positive growth factor that is the most recent average annual percentage rate of change of personal income for Louisiana as defined and reported by the United States Department of Commerce for the three calendar

years prior to the fiscal year for which the limit is calculated.

(2) "Total general revenues" means primary government general revenues from the statement of activities reported in the Comprehensive Annual Financial Report, excluding component units, additions to permanent endowments, and transfers.
