To amend and reenact R.S. 33:9611(A)(1), relative to local ethics entities; to authorize St. Tammany Parish to create local ethics entities and provide for the powers, duties, and authority of such entities; to provide relative to local codes of conduct and ethics ordinances; and to provide for related matters.

The bill was read by title and placed on the Calendar for a second reading.

**HOUSE BILL NO. 293—**

AN ACT

To amend and reenact R.S. 42:457 and to enact R.S. 17:438(E) through (H), relative to labor organizations; to provide for the resignation from labor organization dues or fees for teachers or other school employees; to provide for the resignation from labor organization and union dues or fees for public employees; to provide for collective bargaining agreements or contracts; to provide for applicability; to provide for reporting and notification requirements; to provide for mass transit employees; to allow the secretary of the Louisiana Workforce Commission to waive certain requirements; to require labor organizations or unions to cover administrative costs incurred from the collection of dues or fees and for opting out; and to provide for related matters.

AN ACT

To amend and reenact R.S. 17:8.9(A)(1) and to enact R.S. 17:8.9(A)(6), relative to criminal background checks for persons with an early childhood ancillary certificate; to provide for exceptions; to provide for an effective date; and to provide for related matters.

The bill was read by title and placed on the Calendar for a second reading.

**HOUSE BILL NO. 366—**

BY REPRESENTATIVE DESHOTEL

A JOINT RESOLUTION

The bill was read by title and placed on the Calendar for a second reading.

**HOUSE BILL NO. 428—**

BY REPRESENTATIVES BOURRIQUE AND ROMERO  
AN ACT

To enact R.S. 49:191(1)(o) and to repeal R.S. 49:191(4)(a), relative to the Department of Transportation and Development, including provisions to provide for the re-creation of the Department of Transportation and Development and the statutory entities made a part of the department by law; to provide for the effective termination date for all statutory authority for the existence of such statutory entities; and to provide for related matters.

AN ACT

To amend and reenact Children's Code Articles 603(17)(e) and 610(A)(3) and (4) and to enact Children's Code Article 610(A)(5), relative to mandatory reporting of child abuse or neglect; to provide for police officers or law enforcement officials who work as school resource officers; to establish the information that school resource officers are allowed to receive; and to provide for related matters.
