**(6) The policy of this state is to ensure that transportation of a citizen by ground ambulance be made to the most appropriate medical facility, which may include an alternative destination to a facility other than a hospital emergency department based on a protocol that has been approved by the provider or supplier's medical director.**

B. Every municipality or other local governing authority may protect the public health, safety, and welfare by licensing, controlling, and regulating by ordinance or resolution privately operated ambulance services, the furnishing of emergency medical services, and any and all aspects attendant to ambulance operations within the jurisdiction of the municipality or other local governing authority. Every municipality or other local governing authority is empowered to regulate the following:

\* \* \*

**(7) The establishment of a protocol by all providers or suppliers operating ground ambulance services within the municipality to ensure the safe transport of a citizen to an alternative destination when the emergency medical services personnel has determined that transport to a hospital emergency department is not necessary. The alternative destination may include an urgent care clinic or independent freestanding emergency center.**

\* \* \*

Section 2. R.S. 40:1131(4) is hereby amended and reenacted and R.S. 40:1131.3 and 1133:14(A)(1)(c) are hereby enacted to read as follows:

§1131. Definitions

For purposes of this Chapter:

\* \* \*

(4) "Ambulance service" or "ambulance provider" means any person, firm, association, or government entity owning, controlling, or operating any business or service which furnishes, operates, conducts, maintains, advertises, engages in, proposes to engage in, or professes to engage in the business or service of transporting, in ambulances, individuals who may need medical attention during transport. **Such transport may be made, based on approved protocols, to an alternative destination when the individual can be properly cared for in a location other than a hospital emergency department. The alternate destination may include an urgent care clinic or independent free standing emergency center.** However, "ambulance service" and "ambulance provider" shall not include any of the following:

\* \* \*

**§1131.3 Medical assistance program; ground ambulance transportation to alternative destination reimbursement**  
**The department shall promulgate rules and regulations to provide for a reimbursement methodology to cover alternative destination transport by a ground ambulance service provider to ensure that reimbursement rates are reasonable and adequate.**

§1133.14. Duties of emergency medical personnel

A.(1) A licensed emergency medical services practitioner may perform any of the following functions:

**(c) Determine based on approved protocols whether it is appropriate for a person to be transported by ground ambulance to an alternative destination for care other than a hospital**

(10) Take other action as necessary and proper to implement the provisions of this Section, including but not limited to, the adoption of rules in accordance with the Administrative Procedure Act to provide for the duties and functions of the board.

D. Members. The board shall be composed of thirteen members appointed by the governor. The members shall be subject to confirmation by the Senate.

(1) Members shall serve for terms of four years which shall be concurrent with the term of the governor making the appointments. Each member shall continue to serve until his or her successor is appointed and takes office. A vacancy occurring for any reason shall be filled in the same manner provided for appointment of the membership vacated. Members shall serve without compensation.

(2) The members shall consist of:

(a) Seven members from a list of names recommended by the Louisiana Chapter of the Association of Public Safety Communications Officials.

(b) Four members who are representatives of telecommunications carriers from a list of names recommended by the Cellular Telephone Industries Association ("CTIA").

(c) One member from a list of names recommended by incumbent local exchange carriers operating in Louisiana.

(d) One member from a list of names recommended by cable companies that provide interconnected VoIP services in Louisiana.

E. Meetings.

(1) All meetings shall be conducted in accordance with the open meetings and public records laws. A majority of the members of the board shall constitute a quorum, and a majority thereof may act on any matter within the jurisdiction of the board.

(2) The board shall hold its first meeting not more than thirty days after appointment of all initial members has been completed. At its first meeting, a chairman, vice-chairman, and other officers as considered necessary shall be elected. Officers shall be elected for terms of one year and annually thereafter. There shall be no

prohibition against officers succeeding themselves. The board shall also adopt rules of procedure and may also appoint committees as deemed necessary. Thereafter, the board may meet as often as it deems necessary, but shall meet at least four times per year.
